The questionnaire includes a variety of questions, and requests that the taxpayer provide the earliest date there was a physical presence in the state and the actual date of any tax accounting period in which receipts exceeded \$500,000 in the state.

Texas's statute does indicate that it is possible for tax nexus to exist. However, in the case Quill Corp. v. North Dakota, the U.S. Supreme Court declared that due to the Commerce Clause, a seller must have a physical presence in the state for the state to legally require the seller to collect sales tax.
